A BILL

To require the Comptroller General to evaluate Federal cybersecurity assistance to small business concerns, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Cyber-
5 security Assistance Evaluation Act of 2026”.

6 **SEC. 2. GAO STUDY ON SMALL BUSINESS CYBERSECURITY**
7 **ASSISTANCE.**

8 (a) **SMALL BUSINESS CONCERN DEFINED.**—In this
9 section, the term “small business concern” has the mean-

1 ing given the term in section 3 of the Small Business Act
2 (15 U.S.C. 632).

3 (b) STUDY.—The Comptroller General of the United
4 States shall conduct a study of available Federal cyberse-
5 curity initiatives, programs, resources, tools, and services
6 intended to assist owners of small business concerns
7 with—

8 (1) identifying cyber risks, cyber threats, and
9 cybersecurity vulnerabilities relating to small busi-
10 ness concerns;

11 (2) assessing the preparedness of small business
12 concerns for the risks, threats, and vulnerabilities
13 described in paragraph (1);

14 (3) planning for, mitigating, and recovering
15 from cyber attacks and incidents of social engineer-
16 ing, scams, and fraud, including developing, adopt-
17 ing, and implementing cybersecurity measures, train-
18 ing, protocols, tools, and infrastructure; and

19 (4) identifying sources of capital, or obtaining
20 capital, to carry out the activities described in para-
21 graphs (1), (2), and (3).

22 (c) REQUIRED CONTENT.—The study required under
23 subsection (b) shall include—

24 (1) information on the most common
25 cyberattacks affecting small business concerns;

1 (2) an identification and description of the Fed-
2 eral cybersecurity initiatives, programs, resources,
3 tools, and services included in the study;

4 (3) an assessment of the awareness and use of
5 those Federal cybersecurity initiatives, programs, re-
6 sources, tools, and services by small business con-
7 cerns and reasons for differences in levels of such
8 awareness and use;

9 (4) an assessment of the coordination and inte-
10 gration among those Federal cybersecurity initia-
11 tives, programs, resources, tools, and services;

12 (5) an assessment of the effectiveness of those
13 Federal cybersecurity initiatives, programs, re-
14 sources, tools, and services in assisting small busi-
15 ness concerns with the activities described in para-
16 graphs (1) through (4) of subsection (b);

17 (6) an identification of any foundational cyber-
18 security concepts absent from those Federal cyberse-
19 curity initiatives, programs, resources, tools, and
20 services; and

21 (7) recommendations on how to improve the ef-
22 fectiveness, awareness, and coordination of those
23 Federal cybersecurity initiatives, programs, re-
24 sources, tools, and services for small business con-
25 cerns.

1 (d) REPORT.—The Comptroller General of the
2 United States shall submit to the Committee on Small
3 Business and Entrepreneurship of the Senate and the
4 Committee on Small Business of the House of Representa-
5 tives a report containing all findings and determinations
6 made in carrying out the study required under subsection
7 (b).

8 (e) NO ADDITIONAL FUNDS.—No additional amounts
9 are authorized to carry out this Act.
